### Vision:

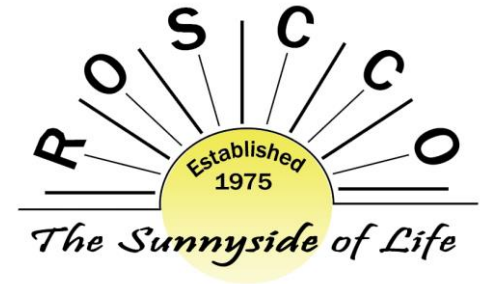

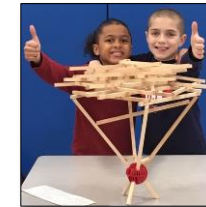

## Treasurer's Report

ROSCCO's financial condition has remained stable while weathering the pandemic thanks to the support of state grants, PPP grants, friends and community partners. This support has enabled ROSCCO to continue programs and services, consistent to our mission, as tuition has not been enough to cover expenses.

Revenues for the fiscal year 2020-2021 total \$1,888,000. Expenses totaled \$1,413,346 for the same period. ROSCCO's total assets \$808,532. ROSCCO is dependent on grants such as these to be able to continue to support the parents of our community by providing safe and affordable care for their children during this most stressful time.
